## LEGISLATION INTRODUCED INTO THE LEGISLATIVE ASSEMBLY ON 20 JUNE 2001

The following Bills were introduced into the Legislative Assembly of Norfolk Island on 20 June 2001:

**Customs (Vehicle Size Limits) Amendment Bill 2001:** This Bill follows an announcement by the Chief Minister on 1 June 2001 that immediate size limits would be imposed on the importation and registration of buses. The Road Traffic Regulations were amended recently to prohibit the registration of buses over a certain size, and this Bill reflects the same size limitation on the importation of buses.

**Supplementary Appropriation Bill 2001:** This Bill provides additional funds for social welfare purposes. The Bill was passed through all stages.
