## TRAFFIC ACT 2010

### TEMPORARY CLOSURE OF ROAD ON THURSDAY 17 DECEMBER 2015

I, Peter Gregory Gesling, Executive Director of Norfolk Island and delegate of the Commonwealth Minister under item 1.171 of the Schedule to the *Minister's Norfolk Island Delegation Instrument 2015 (No. 1)* (Commonwealth) under section 50 of the *Traffic Act 2010*, close that part of the road specified in Part 1 of the Schedule to all vehicular traffic (except any vehicle specified in Part 2 of the Schedule) for the period 6.00pm to 8.30pm on Thursday 17 December 2015 as necessary for public safety purposes and to enable a public function to be held on, or in the vicinity of the road, namely for GO NORFOLK ISLAND PTY LTD to conduct the CHRISTMAS PAGEANT AND PARADE EVENT.

### SCHEDULE

Part 1 – Part road closure: That part of Taylors Road from the eastern side of the entrance to the Norfolk Mall shopping centre to the southern side of the RSL Club (portion 39m).

Part 2 - Exempted classes of vehicles –

- (a) Vehicles authorised by the Administration for delivery of goods or services;
- (b) Administration vehicles involved on official business;
- (c) Police, ambulance, fire services and emergency vehicles on official business;
- (d) Vehicles authorised by OIC Police or delegate thereof.
