# STATUTE LAW REVISION (PENALTIES AND FEES) ACT 1985

Act No. 12 of 1985

---

An Act to provide for the revision of certain enactments

[Assented to 8 May 1985]

**BE IT ENACTED** by the Legislative Assembly of Norfolk Island as follows —

## Short title

1. This Act may be cited as the *Statute Law Revision (Penalties and Fees) Act 1985*.

## Commencement

2. This Act shall come into operation on a date fixed by the Administrator by notice published in the Gazette.

## Amendments

3. An enactment specified in column 2 of the Schedule is amended as set out in column 3 of the Schedule opposite to the citation of the enactment.

## Offences

4. Where an amendment is made by this Act to a penalty in respect of an offence the penalty as amended applies only to an offence committed after the commencement of this Act.
