



STATUTE LAW (MISCELLANEOUS PROVISIONS) (NO. 3) ACT 1986

Act No. 35 of 1986

An Act to provide for the revision of certain enactments and for related purposes

[Assented to 13 October 1986]

BE IT ENACTED by the Legislative Assembly of Norfolk Island as follows —

Short title

1. This Act may be cited as the Statute Law (Miscellaneous Provisions) (No. 3) Act 1986.

Commencement

2. (1) This Act shall come into operation on a date fixed by the Administrator by notice published in the Gazette.

(2) The amendments effected by Item 2 in Schedule 1 shall be deemed to have come into operation on the commencement of the *Dangerous Drugs Act 1973*.

(3) The amendment effected by Item 3 in Schedule 1 shall be deemed to have come into operation on 19 May 1985.

(4) The amendment effected by Item 4 in Schedule 1 shall be deemed to have come into operation on the commencement of the *Ordinances Revision Act 1979*.

(5) The amendments effected by Item 5 in Schedule 1 shall be deemed to have come into operation on the commencement of the *Ordinances Revision Act 1979*.

Amendments

3. An enactment specified in column 2 in Schedule 1 is amended as set out in column 3 in that Schedule opposite to the citation of the enactment.

Insertion of marginal notes

4. An enactment specified in column 2 in Schedule 2 is amended by inserting before the provision specified in column 3 the marginal note set out opposite that provision in column 4 in that Schedule.
