## Statute Law Revision (Status) (No. 3) Act 1986

### Act No. 31 of 1986

An Act to provide for the amendment of certain enactments

[Assented to 1 October 1986]

**BE IT ENACTED** by the Legislative Assembly of Norfolk Island as follows —

#### Short title

1. This Act may be cited as the *Statute Law Revision (Status) (No. 3) Act 1986*.

#### Commencement

2. This Act shall come into operation on a date fixed by the Administrator by notice published in the Gazette.

#### Amendments

3. An enactment specified in column 2 of the Schedule is amended as set out in column 3 of the Schedule opposite to the citation of the enactment.
