CUSTOMS AMENDMENT ACT 1987

Act No 16 of 1987

An Act to amend the Customs Ordinance 1913

[Assented to 16 October 1987]

BE IT ENACTED by the Legislative Assembly of Norfolk Island as follows -

Short title

1. This Act may be cited as the Customs Amendment Act 1987.

Principal Ordinance

2. The Customs Ordinance 1913 is in this Act referred to as the Principal Ordinance.

Interpretation

3. Subsection 1A(1) of the Principal Ordinance is amended by omitting from the definition of "fuel" the word "means" and inserting ", except in subsections 2(1A) and (3), means".

Duty on goods imported for home consumption

4. Section 2 of the Principal Ordinance is amended by -

(a) inserting after subsection (1) -

" (1A) Subject to subsection (2), in addition to duty imposed under subsection (1), duty at the rate of 10 cents is payable in respect of each litre of fuel imported for home consumption.";

(b) omitting from subsection (2) "subsection (1)" and inserting "subsection (1) or (1A)"; and

(c) adding at the end -

" (3) Subsection (1A) does not apply to fuel imported by a registered fuel importer within the meaning of the Fuel Levy Act 1987 and delivered, immediately after importation, to an approved storage facility within the meaning of that Act.

" (4) In subsections (1A) and (3), 'fuel' has the same meaning as in the Fuel Levy Act 1987."

Transitional

5. No duty is payable under subsection 2(1A) of the Principal Ordinance as inserted by this Act in respect of an importation of fuel within the meaning of that subsection occurring before 1 July 1987.
