POLICE OFFENCES (AMENDMENT) ACT 1986

Act No 1 of 1987

An Act to amend the Police Offences Ordinance 1933

[Assented to 18 December 1986]

BE IT **ENACTED** by the Legislative Assembly of Norfolk Island as follows -

Short title

1. This Act may be cited as the Police Offences (Amendment) Act 1986.

Commencement

2. This Act shall come into operation on a date fixed by the Administrator by notice published in the Gazette.

Amendments

3. (1) The provision of the Police Offences Ordinance 1933 specified in Column 1 of the Schedule is amended as set out in Column 2 of the Schedule opposite to the provision specified.

(2) An amendment made by this Act to a penalty in respect of an offence applies only to the penalty for an offence committed after the commencement of this Act.
