HEALTHCARE AMENDMENT NO. 2 ACT 1990

Act No. 10 of 1990

An Act to amend the *Healthcare Act 1989* consequential on the establishment of healthcare levy.

[Assented to 29 June 1990]

BE IT ENACTED by the Legislative Assembly of Norfolk Island as follows —

Short title

1. This Act may be cited as the *Healthcare Amendment No. 2 Act 1990*.

Commencement

2. This Act comes into operation on 1 July 1990.

Principal Act

3. The *Healthcare Act 1989* is in this Act referred to as the Principal Act.

Withdrawals from Fund

4. Section 9 of the Principal Act is amended by omitting from paragraph (1)(g) “subsection 14(2)” and substituting “section 14”.

Revenue of Fund

5. Section 13 of the Principal Act is amended by omitting paragraph (b) and substituting —

“(b) money appropriated by section 20 of the *Healthcare Levy Act 1990*;”.

Appropriation of public works levy

6. The Principal Act is amended by omitting section 14 and substituting —

Refund of healthcare levy

“ 14. If, under subsection 18(2) of the *Healthcare Levy Act 1990*, a refund is to be made of healthcare levy, an amount equal to the refund may be issued from the Fund to the credit of another part of the Public Account.”.

Schedule

7. The Schedule to the Principal Act is amended by omitting the definition of “eligible person” in item 2 and substituting —

“ ‘**eligible person**’ means a person —

- (a) who is a liable person within the meaning of the *Healthcare Levy Act 1990*; or
- (b) who is not a liable person only because the person is not an **adult**; or
- (c) who is not a liable person only because —
 - (i) the person is not an **adult**; and
 - (ii) the person has been absent from Norfolk Island for the sole or principal purpose of attending an educational institution; or
- (d) who is not a liable person only because the person is an exempt person under paragraph 10(1)(a) of the *Healthcare Levy Act 1990*,

but does not include a person referred to in paragraph 10(1)(b) of the *Healthcare Levy Act 1990*;”.

Saving

8. In spite of this Act, section 14 of the *Healthcare Act 1989* as in force before the date of commencement of this Act continues to apply to public works levy paid after that date.
