APPROPRIATION NO. 3 ACT 1991-92

Act No. 1 of 1992

An Act to authorise expenditure from the Public Account for the
service of the year ending on 30 June 1992

[Assented to 13 February 1992]

BE IT ENACTED by the Legislative Assembly of Norfolk Island as follows —

Short title

1. This Act may be cited as the *Appropriation No. 3 Act 1991-92*.

Authority for expenditure

2. In addition to expenditure authorised before the commencement of this Act, the Administration may, for the service of the financial year ending on 30 June 1992, expend money of the Public Account of Norfolk Island for the purposes, and in the amounts respectively specified, in the Schedule.

Expenditure authorised by other laws

3. (1) Section 2 does not authorise expenditure for the purpose specified in item 8/2/01 in the Schedule.
(2) Expenditure for that purpose is authorised by section 40 of the *Social Services Act 1980*, and the amount of money shown in the Schedule in respect of that purpose is an estimate of the expenditure to be made for that purpose under the authority of that section.
