2 CONDOLENCES

Ms Nicholas recorded the passing of -

Allan Samuel Dyer

As a mark of respect to the memory of the deceased all Members stood in silence

The Deputy Speaker took the Chair at 10.16 am

3 PRESENTATION OF PETITION

Mr Buffett presented a Petition from certain electors of Norfolk Island requesting that the House immediately take all action which may be required in order to reinstate Dr. Foong to the position of medical practitioner at the Norfolk Island Hospital; and further that the House institute an independent inquiry into the management of the Norfolk Island Hospital Enterprise by the executive member, the Director and the Norfolk Island Hospital Board

Mr Nobbs moved –

THAT so much of standing orders be suspended as would prevent the Petition being debated

Debate ensued Question put The House voted –

6 STATEMENTS

Mr Smith (Minister for Community Services and Tourism) -

- 1) Advised that the Commissioner of the Australian Federal Police has agreed to assist the Norfolk Island community meet a large part of the costs associated with the current murder inquiry;
- 2) Updated Members on the Tourism Symposium now scheduled for some time in August this year; he also congratulated Mr Bruce Walker on his recent appointment of General Manager of the Tourist Bureau Mr Nobbs moved –

THAT the House take note of the Statement

Debate ensued

Question put and agreed to on the voices;

3) Reported on his recent visit overseas, first to New Zealand where he held positive discussions with Air New Zealand management on the future of the air service they operate to Norfolk Island; and then to Brisbane where he had meaningful discussions with Mr Greg Prechelt of Norfolk Jet Express followed by discussion with the Queensland Minister with responsibility for education on the matter of Norfolk Island trainee ships and apprenticeships

5) Advised Members that the Norfolk Island Youth Centre continued to operate very successfully; it is expected that plans for their new building would be available shortly

The Speaker reported Message No. 5 from the Administrator recommending to the Legislative Assembly the enactment of a proposed law entitled "An Act to authorise expenditure from the Public Account for the year ending June 2003"

8 APPROPRIATION BILL 2002

Mr Donaldson (Minister for Finance) presented a Bill for an Act to authorise expenditure from the Public Account for the year ending on 30 June 2003 and moved –

THAT the Bill be agreed to in principle

The Speaker at 12.25 pm suspended the sitting of the House until 2 pm The House resumed at 2.00 pm, the Speaker taking the Chair

Debate resumed on the question – That the Appropriation Bill 2002 be agreed to in principle
